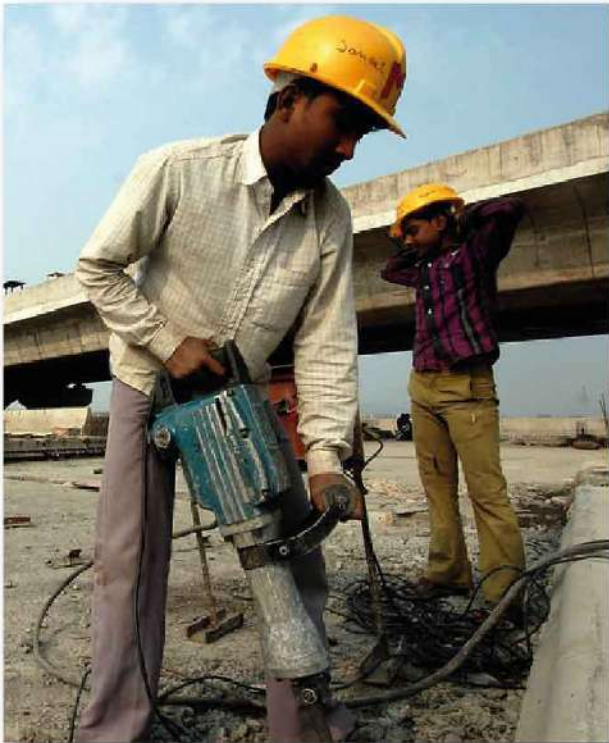

## 1st May - May Day

May this Ramadan bring blessings for the **entire humanity** that we can walk on the way of **peace** and **harmony**!

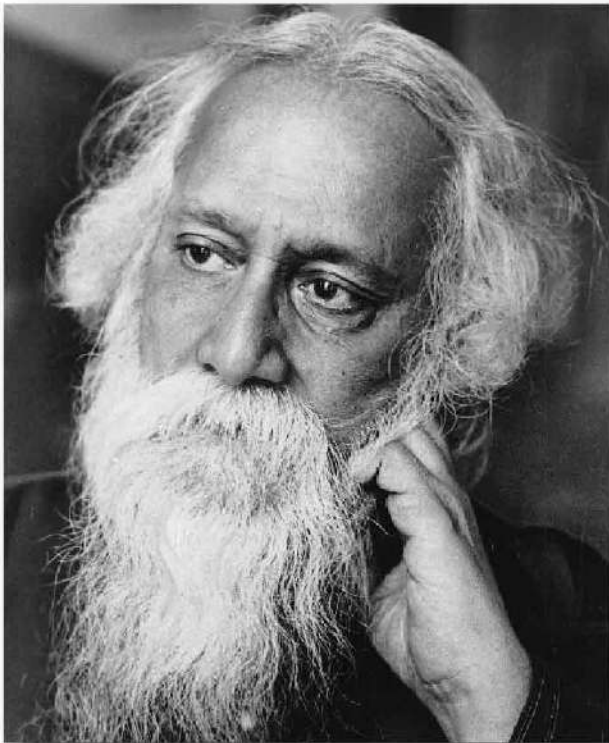


## 8th May - Mother's Day

## In Case: Help Madhuri Save her preterm Twins



Mrs. Madhuri Vidhate the wife of Mr. Ravindhra Vidhate had no idea that their infants would be born **premature**. The twins are currently at Mala Newborn and Children Hospital, Thane, in the NICU, hooked to **machines** and **tubes**, and their health keeps fluctuating day by day. To **breathe**, they need **external oxygen support**. Presently, they are still receiving medical treatment in the form of syrups and drops. Their health is being continuously monitored by doctors to ensure that it **does not worsen** further. The parents are afraid to lose them as they might have to stop the **ongoing treatment** due to lack of funds. To **continue** the treatment need **₹. 10,00,000/-** (Rupees Ten Lakhs Only). Mr. Ravindra Vidhate is the only working member in the family working as a back-office employee earning up to **₹. 8000/-** per month. With such a meager amount, he was hardly meeting the basic needs of the family. Whatever was left was spent on the treatment of his babies. He is **unable** to **secure** any further loans. The family needs your **support** for their younger ones' treatment.

## In case: A spinal deformity has caged Leela's childhood, help her!



Leela is an 11-year-old girl from Thippur, Karnataka. She is a **playful** little girl suffering from a **rare spinal** condition. Her father, Mr. Ramachandra Gowda, and mother, Mrs. Anusaya M. G. work as farm labourers. They collectively earn around **₹ 5,500/-** per month. Leela has a younger brother, Jayant (8 yrs). Leela was diagnosed with **Congenital Thoracolumbar Kyphoscoliosis**. It is a spinal deformity, which occurs due to the **failure** of **vertebral formation** when the child is in the womb. Doctors suggested **bilateral posterior instrumentation** and **deformity correction vertebral** column resection as a part of her treatment. Due to the COVID19 lockdowns, the parents could not take Leela for her treatment and now her condition has worsened. Leela's parents have brought her to Bhagwan Mahaveer Jain, Bangalore for the treatment. They are not able to proceed with the treatment as it's estimated cost is **₹ 5,00,000/-** (Rupees Five Lakhs Only) which is beyond their financial capacity. They are in desperate need of your help.

The doctors suggested that Shristi needs an **Intracardiac Repair** of VSD Closure as a part of her treatment. Shristi's parents then shifted her to Balaji Heart Hospital, Mumbai for the treatment. Here they discovered that the estimated cost of the treatment was **₹ 2,50,000/-** (Rupees Two Lakhs Fifty Thousand Only). With time, medical expenses have exhausted all their savings but with **your help** the family was able to save their child. **Thank you** For helping Shristi.

The babies were in the NICU at Lourdes Hospital, Kerala. The estimated cost of both their treatments collectively is **₹. 6,00,000/-** (Rupees Six Lakhs Only).
